# Foundation Unveils the Sara Low Pin

The Sara Low Charitable Trust Fund made a generous donation to the Foundation following the 2004 Family Assistance Foundation Symposium. Mike and Bobbie Low established the Sara Low Charitable Trust Fund along with their daughter Alyson following the death of their daughter Sara who was killed on board American Airlines Flight 11, September 11, 2001. This generous donation made it possible to create the Foundation lapel pin which has been named in her honor as the "Sara Low Pin".

Paula Morgan, late wife of Foundation Co-Founder, Jeff Morgan, designed the logo for the Foundation shortly before her death in 2000. Since the inception of the Foundation, plans had been made to create a pin bearing the logo for members to wear showing their support for the Foundation and as a symbol of compassionate care for disaster survivors. Each paid member of the Foundation receives a

Sara Low was born in Batesville, Arkansas, October 27, 1972. Sara was outstanding in every way. In high school she was a championship runner, a cheerleader, homecoming maid, and winner of numerous awards. She graduated with honors from Batesville High School in 1991 and went on to the University of Arkansas at Fayetteville to earn her Bachelor of Science degree in finance and real estate in 1995. In 1999, Sara became a flight attendant for American Airlines.

# **Donations for Captain Haynes' Daughter Sets New Record**

Thanks to many of you and many other colleagues in the aviation community, over \$500,000 in donations was raised for Captain

Haynes' daughter, Laurie (Haynes) Arguello. At age 39 Laurie was diagnosed with aplastic anemia. After two years of unsuccessful treatment, her doctors confirmed that Laurie's only hope was for a very Laurie Arguello expensive bone marrow



transplant. Her insurance company needed a \$160,000 deposit before the treatments could begin and then her estimated out-ofpocket expenses were expected to run as high as \$300,000-without extras for complications.

When word went out about Laurie's needs, donations poured in from the aviation community and other organizations from all over

> the world, with many people stating their gratitude for all that her dad had done to help others following the heroic landing of United Airlines Flight 232, in 1989. Captain Haynes has never accepted payment for his talks about the accident, and has always donated money given for his

time to scholarships. Today, Captain Al donates speaker earnings to the National Foundation for Transplants.

According to Janice Hill, Manager of Communications, National Foundation for Transplants, Laurie's recovery has been comparatively guick and without severe complications. She is back at home and feeling well. In addition to the activities involved in being the mother of a 10-year-old boy, she is researching job possibilities she will want to pursue once her doctor gives her a release to return to work, as most BMT patients are told to wait approximately one year before returning to work full-time.

# **Certification for Trauma Workers & Responders**

In the 1980s, trauma specialists with the National Organization for Victim Assistance (NOVA) and the International Society for Traumatic

Studies Stress (ISTSS) were concerned with the quality of treatment available to survivors of traumatic events. The Mental Health Task Force at NOVA and the adhoc Committee for the Development of Criteria for the Certification

ors at ISTSS contributed concepts, criteria and work to begin to set minimal standards of education and experience for trauma counselors.

> was hoped that It and ISTSS NOVA would join with the National Victim Center to create an umbrella organization to review and approve certifications. Both NOVA and ISTSS determined that the initiation and maintenance of a certification program was beyond the scope of their organizations' purposes and funding capabili

ties. Consequently, in 1989, the founding members of ATSS, all of whom had been involved in the initial efforts with NOVA, ISTSS or both, made the decision to create the International Association of Trauma Counselors which is now called the Association of Traumatic Stress Specialists or ATSS.

### Why Do You Need Certification?

Certification offered by ATSS recognizes an individuals specialized trauma education and experience in treating traumatic stress. ATSS is committed to providing professional recognition for an indi-

vidual's unique training, experience and education in traumatic stress. People who meet these criteria deserve professional recognition which acknowledges their commitment to quality trauma treatment.

### Is ATSS Certification Available To Individuals Who Do Not Provide Clinical Treatment To Trauma Victims?

Yes! ATSS is an international membership organization committed to recognize the specialized education, experience and skill of individuals who provide trauma response, treatment and services. An individual is not required to have a college degree to become certified as long as they meet standards of training, experience and currency in the field as established by the ATSS Certification Board. We welcome individuals, volunteers, students, retirees and agency/teams within our membership ranks that represent law enforcement, military, clergy, victim services, disaster work, public safety, firefighting, health care, employee assistance, business and industry, social work, medicine, research, education, government - anyone interested in improving services to victims and survivors of traumatic stress.

# Which Certification is Right for You?

ATSS offers three distinct international certifications for individuals representing a number of disciplines. You may be eligible for designation as a Certified Trauma Responder (CTR), Certified Trauma Specialist (CTS) or Certified Trauma Services Specialist (CTSS).

**CTR** recognition is for those individuals who provide immediate trauma intervention through crisis management, debriefing, peer counseling and trauma response. **CTS** recognition is certification offered for counselors and treatment specialists who provide individual, group, and/or family counseling to trauma survivors.

**CTSS** recognition is for those who provide immediate trauma and crisis intervention, crisis support, advocacy or victim assistance.

An individual may hold one, two or all three certification recognitions. Qualifying factors are based on experience, education, training and currency of work.

### Why Do I Need Certification? I Have An Advanced Degree And/Or State License That Qualifies Me To Treat Trauma Survivors?

Survivors need to know they can find specialized help. ATSS Certification recognizes that you have specialized education and experience in treating traumatic stress. Indeed, your existing credentials are invaluable in assisting ATSS in maintaining integrity and professionalism among trauma treatment providers. ATSS is committed to providing professional recognition for your unique training, experience and education in

traumatic stress. You deserve professional recognition, which acknowledges your commitment to quality trauma treatment.

While ATSS is dedicated to set-

ting standards of excellence for improved response to trauma victims, ATSS does not take the position that anyone must be certified or that only certified members can provide quality services. Trauma treatment specialists should also establish and control their *own* standards of excellence and accountability.

### Where Can I Get Training That Meets The Educational Requirements For Certification?

As a member of ATSS, you will automatically receive notice of, and member rates for our annual international conference. This training meets the criteria for accredited coursework. Organizations that provide training consistent with ATSS certification requirements include:

# **Independence Air Joins** Foundation

The Family Assistance Foundation is pleased to announce that Independence Air has joined the Foundation as a full airline member.

Independence Air was officially born on November 19, 2003 as the new airline of Atlantic Coast Airlines (ACA). Up until this

time ACA had operated as either a United Express or Delta Connection carrier. ACA, based in Dulles, Virginia flew their first passengers for United in 1989 and in 2000 started also operat-



ing as a Delta Connection Carrier in partnership with Delta.

In December, 2002 United Airlines filed for bankruptcy and with the subsequent issues that followed ACA decided to declare it's "independence". Independence Air flights began officially on June 16, 2004. Independence Air will operate a fleet of at least 112 jets, including 25 Airbus A320/A319 aircraft as well as 87 CRJ's. By September, 2004 the Independence Air schedule grew to 600 daily departures with its Dulles, VA hub becoming the largest low fare hub in the United States.

Independence Air is also retooling its emergency response and family assistance program under the leadership of Chris Woods, Safety Specialist-Emergency Response. While ACA's previous emergency plan was heavily dependent upon its partners, United and Delta, the new airline operation required a new standalone program. Chris and his team have made great strides in developing a world class program and have created their own new family assistance team known as the "iCare Team". Independence Air will utilize its own iCare Team in partnership with the Family Assistance Foundation to ensure it can provide effective and compassionate assistance to their passengers and families in the event of an accident.
